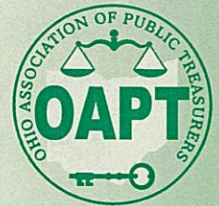

I look forward to seeing as many of you as possible very soon.

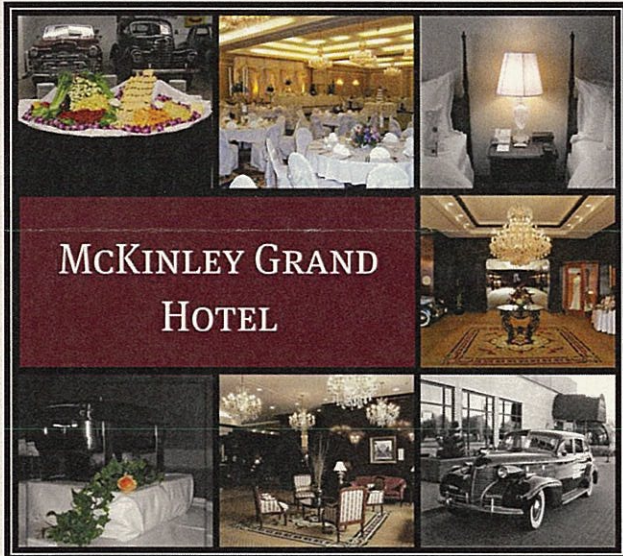

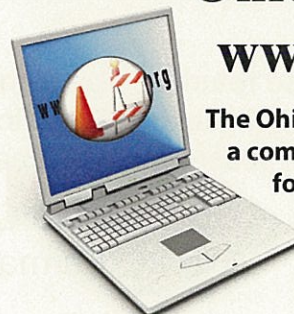
