

We have a great summer and fall in store for our members. The June Finance Training, Hot Topic Seminar, Workers Compensation Pool and our Annual Fall Conference in October. The June Public Finance Officer Training Institute is complete and final agenda will be emailed. It is scheduled for the Kalahari Resort and Convention Center in Sandusky, Ohio, June 9th-14th. The maintenance program will be June 12th & 14th. There will be an opportunity to earn CPIM, CPE's, CPFA's and ACPFA's. The early-bird registration for the full-week program is \$485 and \$285 for the two-day maintenance program. The Kalahari has the largest indoor waterpark in the country and a premier expanded convention center. The negotiated room rate of \$119/night also includes, at no extra charge, 4 waterpark passes. Register early to secure your spot and take advantage of the early-bird rate.

The OAPT annual fall conference will be at the Geneva State Park Lodge, on Lake Erie, October 8th – 10th. We promise to provide you with a great value by keeping our registration fees low and we have negotiated a room rate of \$95 per night with free parking. We plan to have our Wednesday Night in Wine Country with dinner at a local Winery. The theme for our annual Thursday Night Banquet will be 1930's and 1940's Hollywood. We again plan to provide you with the opportunity to meet some, or all, of your professional certification requirements through attendance at the conference.

History of the Ohio Association of Public Treasurers

In the early 1960's there was a movement to eliminate the position of Treasurer in the State of California. In 1965 the California Municipal Treasurers Association was founded with the purpose of educating City Treasurers and retaining the position of Treasurer in the cities of California. Other states in the west followed suit and in 1967 formed the Municipal Treasurers Association of the United States and Canada. The MTA US & C held their first conference in Washington DC. In 1973 and 1974 Parma Treasurer Anna Kozusko attended the MTA National Conferences and brought back the idea of chartering an MTA chapter in Ohio.

In 1974 the Ohio Municipal Treasurers was founded. Anna Kozusko the Treasurer of the City of Parma, John Cannone the Treasurer of the City of Parma, Jim Dye the Deputy Treasurer of the City of Akron and Bob Warner from the Union Commerce Bank of Cleveland meet at the Holiday Inn in Independence and charter the Ohio Chapter of the Municipal Treasurers Association in the Summer of 1974. Ivan Otto, a partner at Squires Sanders & Dempsey, was the legal council in the formulation of the By-Laws. The Ohio Municipal Treasurers held their first Conference in the fall of 1974 in Sandusky, Ohio. The first honorary guest speaker for the Association was Woody Hayes the legendary coach of the Ohio State Buckeyes football team.

In the State of Ohio there was no formal training program for Village and City Treasurers. The Ohio MTA was organized for the purpose of preparing and educating Municipal Treasurers throughout the state. In 1976 the OHIO MTA sponsored and chartered the Michigan MTA.

In 1980, the Municipal Treasurers Association of the United States & Canada established criteria for the Public Finance Officers Training program to become a Certified Municipal Finance Administrator. The Ohio APT lead by MTA National President John Cannone contracted with Dr. James Tinnin at Kent State University to have a yearly Finance Officers Training Program. Kent State University administrated the Program for many years. Budget cuts at Kent State prompted the Ohio APT to continue the program at the University of Akron. In 2010 further budget cuts in the State Budget caused the University of Akron

to discontinue the Program. In the fall of 2010 the Ohio APT partnering with the John Glenn School at Ohio State University and the Public Treasury Institute continued the program internally with Administrator Jack Krise, Jr. and Education Coordinator Sal Talarico. The Finance Training Program continues to offer Ohio Public Treasurers the CPFA certification.

The Public Treasurers Association of the United States and Canada has held two of its national conferences in Ohio. Cincinnati in 1984 and Cleveland in 2001. Six National Presidents have come from Ohio, John Cannone, Akron; Jack Cross III, Cleveland; Ed Volpe, Cincinnati; Jack Krise, Jr., Parma; James Bell, Huber Heights; and Dana Kavander, Berea.
