


Where are the Unemployed?

U.S. consumer-price index, change from one year earlier




U.S. consumer prices, change since January 2020



Note: Seasonally adjusted Source: Labor Department





U.S. median sales price of existing homes



Deep in Debt


National debt and the statutory limit
