Speaker Biographies

Roger Peterson has been with Geauga County for over 10 years, and he currently serves as Director of Emergency Services. Prior to Geauga County, he served as Fire Chief, then worked with Emergency Planning Safety and Environmental Health. He is currently a volunteer Firefighter/Paramedic and a Township Trustee in Bloomfield Township, Trumbull County.

Scott Weisend has over 38 years' experience in the field of Ohio and National workers' compensation, including claims management, hearing representation, account management, sales and multiple areas of leadership. Scott has been with Sedgwick for over 13 years in sales and sales leadership.
